

Judo Victoria Inc: Policy Documents

STATE SQUAD SELECTION CRITERIA

Last revised July 2014

Purpose

This policy is designed to set out the Victorian Judo State Squad selection criteria.

Scope

This policy applies to the selection of members to represent Judo Victoria Inc as part of the Victorian Judo State Squad in the Judo Federation of Australia National championships.

The squad selection process is performed on an annual basis.

Standard Selection Criteria

There are five annual criteria for members to be considered for the Victorian State Squad:

1 State Squad Training

- Candidate must participate in a minimum of 60% of state squad training sessions during the pre-nationals training cycle

2 JVI competition participation

Nominating candidates must have competed in:

- Most recent JVI Victorian State titles (as they occur between national championships); and
- A minimum of two JVI competitions (in addition to the state titles) that occur in the twelve month period between national championships

3 Australian International Open Circuit

In order to demonstrate capability at the national level the candidate must have competed in either:

- The most recent international open held in Victorian (e.g. SCIO); or
- Two international opens held in other states (e.g. ACT, NSW, QLD, SA)

4 State squad coaches confirmation

Candidate must receive:

- Acceptance by the majority of the relevant (junior or senior) official state team coaches plus the state team manager that the candidate is suitable for nomination to represent JVI at the national championships

5 Committee Sign-off

- The JVI Inc. committee must sign-off on all nominated state squad members

Exemptions from criteria

Exemptions from any of the above criteria may be granted to a candidate on one of the following basis:

1 Injury

An injury has been sustained that prevented the candidate from achieving one or more of the selection criteria

- Evidence required: Medical certificate
- Resolution process: Medical clearance to compete required and state team coaches confirmation (as per selection criteria) required

2 Work / School commitments

Work or schooling circumstances have arisen that prevented the candidate from achieving one or more of the selection criteria

- Evidence required: Letter from employer / school
- Resolution process: Evidence of supplementary training required with sign-off from an accredited JVI Coach and state team coaches confirmation (as per selection criteria) required

3 Family circumstances

Family circumstances have arisen that prevented the candidate from achieving one or more of the selection criteria

- Evidence required: Letter outlining circumstances to coaches
- Resolution process: Evidence of supplementary training required with sign-off from an accredited JVI Coach and state team coaches confirmation (as per selection criteria) required

4 Overseas training / competition

Candidate has been training / competing overseas and/or representing Australia

- Evidence required: Letter from JFA or other official body (e.g. IJF / Kodakan)
- Resolution process: State team coaches confirmation (as per selection criteria) required

5 New to Judo

An athlete is sufficiently new to the sport such that grading requirements prevented them from achieving a required criteria

- Evidence required: Date of JVI registration and grading
- Resolution process: State team coaches confirmation (as per selection criteria) required
