KATA COMPETITION CONDITIONS

- The Kata contested will be Ju-no-Kata, Kime-no-Kata, Katame-no-kata, Nage-no-Kata, Junior Nage-no-kata, Kodokan Goshinjutsu.
- Enter ONLINE at <https://judovictoria.com.au> : select EVENTS then ENTRIES. **Entries close at midnight Wednesday prior to the event.**
- Entry Fees: \$20.00 per person (\$40.00 per pair).
- Venue is Broadmeadows Aquatic & Leisure Centre, 63 Tanderrum Way, Broadmeadows
- No Credit/Debit card facilities are available for spectators at the venue, CASH only.
- If you cannot attend on the day, please call Lynnette Slade on 0408 059 171. A \$10 administration fee will be charged for all refunds. A competitor who withdraws after the online closing date, and wishes to obtain a refund, must provide a Doctor's Certificate stating that they are not fit to compete. This certificate must be supplied within 3 days of notifying Lynnette Slade. See JVI Competition Refund Policy
- The Kata tournament will be conducted in accordance with the JVI Kata Sporting Code <https://judovictoria.com.au/wp-content/uploads/2018/05/Judo-Victoria-Inc-Kata-Sporting-Code-3-2017r.pdf> and the IJF Kata Evaluation Rules https://judovictoria.com.au/wp-content/uploads/2017/08/ijf_kata_evaluation_jan_2015.pdf .
- A White judogi is compulsory which must comply with competition (shiai) requirements.
- A player's age is calculated by the calendar year (ie on 31 December of the year) and not the day of the competition.
- An 8m x 8m contest area will be used.
- Competitors must be current financial members of JVI.
- Please bring your white JVI Membership Card and advise if you are also competing in shiai divisions on the same day.
- Competitors have Insurance cover as financial members of JVI through JFA Insurance Policies, please peruse these policies to ensure you are covered to meet your needs.
