

2023 NATIONALS REPORT

First, I'd like to acknowledge my gratitude to the coaching team (Carli, Douggie, Neel, David, and Hunter), our managers (Sandy, Maria, and previously Derren and Angelique) for all their hard work in coaching and managing the squad.

This could not have been achieved without the passion they have for Judo and sacrificing their time (and sometimes health) for this cause.

After 4 months of training at the National Performance Centre in Albert Park, the Victorian Squad was represented by over 100 players, collecting 19 Gold medals, 17 Silver medals, and 25 Bronze medals, including a Senior Boys and Girls team Silver medal.

During the preparations we faced several issues, however, the National Championships overall were very successful for Victoria. We had a few incidents during the event itself which have been dealt with during the weekend.

We have received many messages from parents and athletes who were very happy with the coaching on the weekend, and at the same time were less than happy with how the event was run by JA. With a new technology being used (Judo Manager), the very first day had a delay of nearly an hour for the Junior Boys and Girls, and a different issue relating to the way JA draw divisions could not display the order of fights on one of the screens. This resulted in delays and a bit mayhem, especially with the Junior Boys and Girls.

Post-Nationals, all the coaches and current team managers have expressed their interest to continue with the Squad in 2024. We have commenced our review of what issues we can remediate and improve for next year. We will continue to review and implement these before the next season commences.

One of the items which we must address sooner rather than later is the venue question. While the NPC, as a Dojo, is probably the best we have at the moment, and CombatAus are happy to have us there again next year, the venue itself poses a few issues to the Squad.

These include:

- General access we do not have a key and must rely on CombatAus to provide access on the day. There's also an issue when SMFC have games, the shop is open, and the path to the mat is narrower than usual.
- Access for parents when the café is closed we are not allowed inside unless we rent the place out in addition to renting the mat area. Spectators are not even allowed on the ramp.
- Parking during events we had a few weekends where parking was challenging due to large events at Albert Park, resulting in many athletes being late for their training sessions
- Grand Prix weekend parking issues and one weekend we could not access at all



The coaching and team managers will continue their review over the next few months before communicating the outcome to the broader CoM, club coaches, athletes, parents, and volunteers.

Judo Victoria thanks all our State Coaches and Managers in the 2023 State Squad Program. Thank you to the parents who supported the program during training and at the Gold Coast.

Kata Committee

I am pleased to present the Annual Report of the Kata Committee for the financial year 2022-23.

Our dedicated committee has been actively engaged in enhancing the understanding and appreciation of kata within our Judo Victoria community. Our efforts have been directed towards preparing our members for Dan Grading, equipping them to compete at Nationals, and, most importantly, fostering a deeper interest in kata among our members.

In 2022 our third seminar gave JV members the choice of kata they wanted to learn and our fourth was held in Drouin where we covered Nage no Kata and then gave the participants a choice of three kata to work on in the last session. In 2023 our first seminar focused on Nage no Kata and Goshin Jutsu and our second seminar focused on Kime no Kata and Katame no Kata as we had to prepare our members to compete at Nationals.



A total of 73 members participated in the four seminars held this financial year, an average of 18.25 per seminar. At the end of each seminar, we ask all participants to fill out a feedback sheet, to ensure we take the participants' opinions into our next planning meeting. The Appreciation Quotient, (perfect being 5), ranged from 4.68 to 4.93, which is excellent. We held a total of nine Kata Sub Committee meetings over the year via Zoom.

We had planned to put on a kata demonstration at each JVI Competition to build up the profile of kata with our JVI members, but sadly, one of our demonstrators dislocated his collarbone, so was out of action for six months. We did get Roy Worner and Tahlia Blackman to present Kime no Kata at one competition and Katame no Kata at another competition.



In conclusion, the Kata Committee remains committed to its mission of nurturing a strong and passionate kata community within Judo Victoria. We have made significant strides in the past year, with increased participation in seminars and the incorporation of kata into our competitive events. Despite challenges, we are determined to persevere and continue our efforts to elevate the profile of kata within our organisation.

We extend our gratitude to all members who have been a part of this journey, and we look forward to another productive year ahead.

TREASURER'S REPORT – EOFY JUNE 2023

The financial statements for EOFY 2023 were audited and had been issued with an unqualified opinion by our external auditor EWM, Accountants and Business Advisors.

Basis of accounting preparation and measurement:

The financial reports are prepared in accordance with the Australian Accounting Standards and to meet the reporting requirements of the Association Incorporated Reform Act 2012 (Vic).

Judo Victoria Inc is a not-for-profit entity for the preparation of financial reports.

The financial reports have been prepared on an accrual basis:

- That is income is reported when they are earned and expenses reported when they are incurred, not when they are paid
- The result of accrual accounting is to present a fair view of profitability of the period when expenses are matched with revenue

Income Tax

The association is exempt from income tax under Division 50 of the Income Assessment Act 1997.

Financial Overview & Result 2023

For the financial year ended 30 June 2023, operating surplus was \$27,916, but with passive income from Covid -19 business grants and depreciation added back ended with a realised surplus of \$32,085

Balance Sheet - Changes in Equity

JVI had recorded an increase in equity of \$29,916 in EOFY 2023. This resulted from the following:

- Grant received \$2,000
- Surplus for the year \$27,916

Cash Flows

JVI recorded an increase in cash held of \$22,160 primarily as a result of cash inflows of business grants received under COVID-19 and in funding operational and capital activities.



Impact of COVID - 19:

- In the aftermath of COVID 19, and with the slow return to normalcy, Judo Victoria's (JV) stocktake of the COVID effects reveals loss of 3 Clubs, and fallen membership's income for EOFY 2023 of \$55,292 reflected slow recovery.
- JVI lost many volunteers or faced a decline of volunteers due to extended lockdown or a hesitant to re- engage.

JVI continued to sustain the reach and enhancement to members during the year in the following outgoings of \$71,192

- Sport Development Travel grant to elite and emerging athletes \$5,000
- Other services First Aid, Dan grading, Katas \$7,654
- Operations Volunteer awards \$3,124
- Capitation fees \$11,208
- National outgoings \$20,898
- JA Insurance 2023 2024 \$23,308

Challenges and opportunities

- JV acknowledges the big challenges at enticing and retaining volunteers as we recover from COVID-19. The old ways of attracting and retaining volunteers are no longer effective and different approaches will be acquired to provide support to the community in the participation of judo as not only as a sport but an active recreational sector.
- These challenges require collaborations and partnerships with VICSPORT to build capability of workforce to ensure sustainable sector.

JVI's strategic plans for 2023 -2024 will target the following areas:

- Governance and review of its constitutions (on-going process)
- Risk management
- Identifying the needs of disability group

The outcomes:

- Systems improvements and business practices
- Aligning in partnership with VICSPORT to strengthening good governance and business practices
- Greater engagement with working parties to improve website and social media
- Strengthen relationships and partnerships with clubs and members

Financial position and liquidity

Judo Victoria financial health remained strong and liquid to meet unforseen increases in operating expenses or decline in income. Despite this we must remain diligent, dynamic and innovative. The organisation depends largely on its stakeholders for grants. Membership fees for live and club members have been kept on hold without increase and without GST. JVI has been accepting these

financial challenges in a lower income from members and increase in insurance and capitation fees (on hold since COVID) from the national body.

The organisation has no borrowings.

There has been no significant changes which may impact the nature of the activities of the organisation

Judo Victoria acknowledges the generous grant support from Sports Recreation Victoria (SRV, DJPR, DJSIR) and for their continual support of sport and activities.

Judo Victoria appreciates the continuing dedication of staff, volunteers, and advice of consultant without which we would not be where we are now for their hard work and timely support given throughout the year.
